

For more than 17 years, the North Carolina Composting Council (NCCC) has brought together dedicated & passionate composting leaders from across the state to advance composting & sustainable waste management practices. With the support of a part-time Executive Director for the past two years, NCCC continues to expand its programs and gain sponsors, members, & partnerships.

NCCC funding also goes to pay for a dedicated lobbyist, Nick Wood of Blue Heron Lobbying & Consulting LLC. Having a dedicated lobbyist serving the needs of the composting industry provides an invaluable connection to the NC General Assembly, where the NCCC continues to develop relationships and educate legislators.

NCCC operates through a strong committee-driven structure & an actively engaged working-board. Our regional chapters and committees remain central to advancing our mission statewide—including our Education and

Outreach (EOC), Advocacy & Access (AAC), & the Compost Operations Training Course (COTC) Committees. Meetings continue to be held primarily online to maximize accessibility & participation. All committees welcome new members! NCCC extends its deep appreciation to the many volunteers who contributed their time and expertise this year through board service, committee work, and event support.

In 2025 NCCC added 4 new Board Members: Mallorie Ferrigno, of Atlas Organics, Brandis Strickland, of Truist Bank and Organic Life Amendments, Trey Alber of Wilmington Compost Company, and Rita Meriergerd of McGill! Regional Chapters

A major area of growth for NCCC in 2025 was the formal establishment of regional chapters, enabling our mission to take root more deeply at the community level.

The Coastal Composting Chapter, which has collaborated with NCCC in the Wilmington region for more than seven years, continued to expand its local initiatives, including outreach events, the Garbage to Gardens school composting program and pumpkin diversion events.

This year also marked the successful launch of the Mountain Composting Chapter, supported by the leadership of NCCC Board Member Christine Wittmeier and Jen Maxwell, Appalachian State University Sustainability Director. Together, these chapters strengthen NCCC's statewide presence and foster more localized engagement, education, and action.




2025 expenses

The NC Compost Operations Training Course (COTC)

NCCC's Compost Operations Training Course (COTC), hosted in partnership with the Compost Research and Education Foundation (CREF), remains a flagship program for NCCC. In 2025, the course welcomed 33 students from across the globe, reflecting its reputation as a premier training opportunity in the composting industry. NCCC continued its strong collaborations with NC State University, the City of Raleigh Yard Waste Center, the City of Durham Solid Waste Department, McGill Compost, Atlas Organics, and expert volunteers statewide, all of whom play a vital role in delivering this high-quality program.

This year, NCCC awarded two scholarships to support greater access and representation within the field; scholarship recipients were from North Carolina and Mexico. We were proud to host students from 12 states and 4 countries in 2025! Special thanks to NCCC's COTC Sponsors, whose generous support makes it possible to offer an exceptional, hands-on compost operations training experience.

2025 Annual Meeting

For Members & Supporters

NCCC's 2025 Annual Meeting for Members and Supporters, themed "Strong Economies and Communities Start with Compost," highlighted composting's vital role in building resilient local systems and the strong economic opportunities within North Carolina's composting industry. In mid-June, more than 50 professionals from diverse backgrounds gathered at NC State University's Plant Sciences Building. Dr. Chyi-Lyi (Kathleen) Liang delivered a keynote on entrepreneurial strategies for integrating composting into community development.

Attendees also heard from leading North Carolina composting experts, the US Composting Council's Executive Director, updates on the NC Council's recent legislative work, and reports from grant recipients and the Board of Directors. An expert panel featuring Kate Sullivan (McGill), Sarah Justice (Town of Cary), Frank Franciosi (US Composting Council), David Valder (Crown Town Compost), and Dr. Liang (NC A&T) explored compost's role in infrastructure, policy, and agriculture.

The day was highly interactive, and we are grateful to Wanu Organics and XFORMS for sponsoring the event.

App State University



App State University expanded on-campus food scrap collections by adding a roofed-structure & compost-collection system, serving as a model for the community. App State also expanded collaborative solid waste management efforts in the high country to establish the Mountain Composting Chapter of the NC Composting Council!

Making Pitt Fit Community Garden



Making Pitt Fit Community Garden expanded their vermicompost system and educational composting programs in 2025. This grant also enabled participating schools and community groups to engage with an ongoing vermicomposting project!

Sustainable Sandhills



Sustainable Sandhills, in collaboration with Organic Life Amendments and Cumberland Mills Elementary School, launched and maintained a school composting pilot program, aiming to connect their community, educate youth, and collect metrics for a robust composting outreach program!

Cultivating What Comes Next **2026**

Regional Chapter Formation & Growth

NCCC is expanding its capacity through the formation of official regional chapters, enabling organized groups of leaders and stakeholders across the state to increase our reach and impact. The Coastal Composting Chapter—active since 2017—continues to lead composting programs and educational outreach in the Southeast coastal region. In 2025, NCCC formally codified regional chapters and added the Mountain Composting Chapter to serve Western North Carolina as well.

Compost Corps Workshops

In 2026, NCCC hopes to expand educational opportunities both in person and online to meet the statewide need for support in starting and maintaining small-scale composting systems. To address this, NCCC plans to pilot, if awarded grant support, a Compost Corps workshop series to train composters across North Carolina and produce a professional “how to start and maintain a 3-bin composting system” video, which will be available for free on NCCC’s YouTube channel.

Compost Capital & Financial Literacy Workshop

NCCC, in partnership with Wanu Organics, will host a compost capital and financial literacy workshop in the Raleigh–Durham area in 2026. Designed for both emerging and established compost business owners, this workshop will strengthen financial literacy specific to composting and hauling operations and connect participants with local and regional resources to help grow their businesses.

Increased Industry Engagement

Building on success from the 2025 NC Compost Operators Training Course (COTC), NCCC is working to expand opportunities in North Carolina for compost facility tours and equipment demonstrations. NCCC will continue working with a lobbyist to further the composting industry’s interest in State rules and legislation. We will utilize this year’s UNC-Capstone study findings to build a legislative agenda for the year to come.
